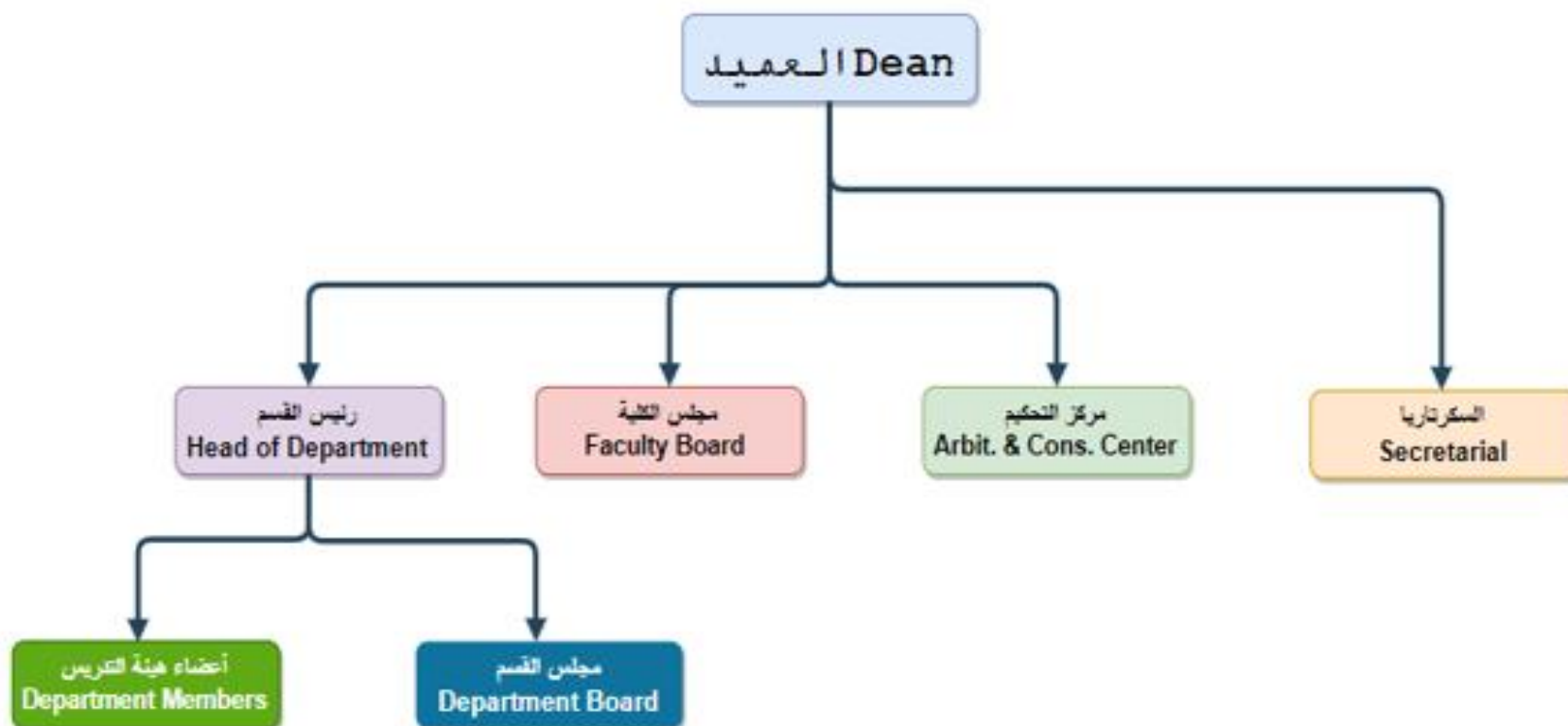
# **ASU..**

## كلية الحقوق - الهيكل التنظيمي Faculty of Law - Organizational Chart

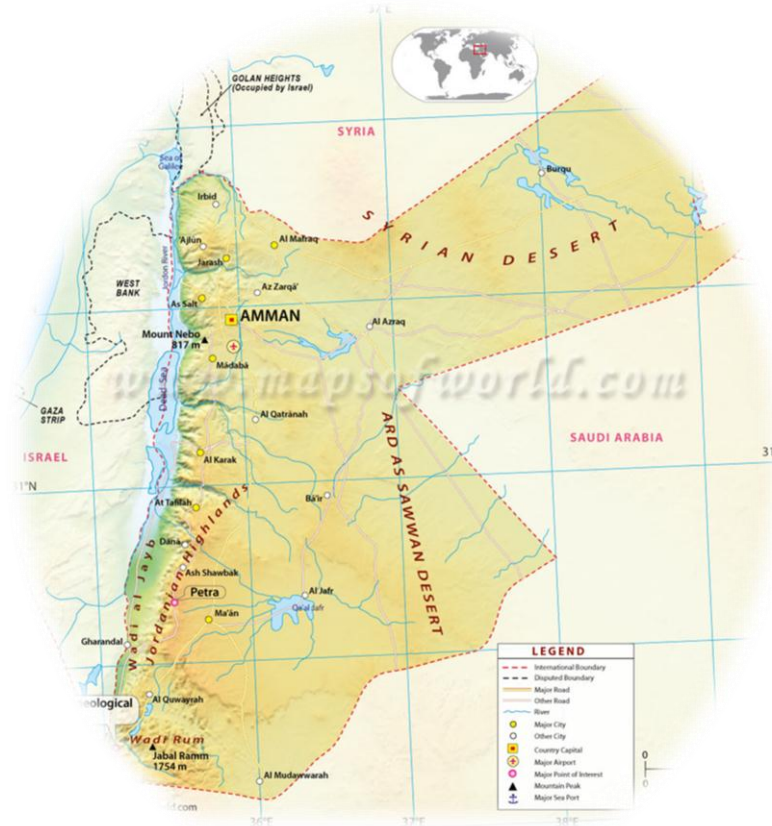
